Order #11667 - Motion Passed: Establish tax rate of 50.2 cents per \$100 of assessed property value for real property and 53.3 cents per \$100 of assessed property value for personal property, which includes the remaining SY 2023-2024 unbilled portion of the recallable nickel of 4 cents per \$100 of assessed property value for both real and personal property approved by the ACBOE on 8/24/2023. Additionally, establish the motor vehicle tax rate at 51.8 cents per \$100 of assessed property. The district will allocate three nickels (FSPK, EFF, Recallable) to the building fund and the remaining to the general fund.
