### Metro United Way Agency Investment Agreement 2023-24

#### **Purpose and Expectations**

Metro United Way (MUW) is investing in your organization as detailed in the funding letter, recognizing your efforts to provide quality services that support Thriving Kids, Strong Households, and Equitable Communities. These funds are not restricted and may be used for general operating expenses.

Failure to meet the following criteria may result in MUW ceasing funding to your agency and pursuing reimbursement. It is imperative that agencies notify Metro United Way immediately in the event of any significant changes to program(s) funded by Metro United Way.

- Meet service expectations by continuing the funded program and achieving the goals and outcomes stated in your funding proposal.
- Meet impact reporting expectations by submitting the completed Annual Report to Metro United Way.
- Strive to demonstrate organizational best practices by meeting the standards of the Better Business Bureau Charity Review.

## **Exempt Status**

You have represented to Metro United Way that the Internal Revenue Service has ruled your organization or its fiscal agent to be a federally recognized tax exempt, not-for-profit organization. Any change in this status must be communicated to Metro United Way immediately.

### **Diversity, Equity and Inclusion**

Your agency must demonstrate a commitment to model diversity, equity and inclusion as stated on the Metro United Way website. #### Communication

Metro United Way views the agencies we fund as partners and enjoys open communication with them. If your organization experiences major changes, MUW should be notified immediately. Examples of major changes include:

- Any significant transition, including at the executive or key program staff level, financial concerns, or challenges.

#### **Termination of Metro United Way Investment**

Either party may terminate this agreement by notifying the other party in writing. The notice must include the reason for termination and the selected termination date. All investment payments will be suspended at the date of the termination, unless otherwise agreed upon.
