**Recommendation/Motion:** Appoint Amanda Ferguson to be the Board representative and approve the membership of the Local Planning Committee (LPC) for the 2025-2029 plan cycle as set out below.

**Background/Rationale:** The Kentucky Department of Education in its Facilities Planning Manual outlined the make-up of a Local Planning Committee (LPC). It shall be made of 20 (twenty) members to include: the Superintendent (or designee), 4 parent members, 4 teacher members, 4 building administrators, the district facilities director (or designee), 1 central office staff member (certified or classified), 3 community leaders, a local building/zoning official, and 1 board member. A maximum number of representatives from each school cannot exceed 1 (one). The parent representatives shall be elected by the PTA/PTO in each school. The selection of the teachers and building administration representatives can be made by any process developed by the teaching/administrative staff. The Central Office staff member must be elected by those assigned to Central Office. The Community Leaders and Board member must be selected by the Board. The proposed committee is:
