Recommendation/Motion: Approve a revised BG-1 Project Application for the construction of the New Henry Clay High School in the amount of \$185,600,276.32 (One Hundred Eighty-five Million, Six Hundred Thousand, Two Hundred Seventy-six Dollars and Thirty-two Cents).

Background/Rationale: The construction of the New Henry Clay High School is listed as priority 1b.3, 5.21, and 5.22 on FCPS's 2021 District Facility Plan (DFP) amendment #2 of approximately 348,778 SF to serve 2,300 students.

During the design phase of the project, the design team is required to revisit the cost opinion as the design becomes more detailed. If the design team finds that the cost opinion changes greater than 10% at any phase of the design, they are required to let FCPS know this in order to recommend revising the BG-1. Based on current trends in the construction industry, we are seeing an increase in construction costs. It is recommended to approve a revised BG-1 as listed.
