#### **Division 03: Concrete**

03.01: 2024.09.03 – Area B foundations and footings appeared complete. Work was active in Area A, along Line E.5

03.02: 2024.09.17 – Slab on grade had been poured up to Line 7 at the north end of the building. Vapor barrier was observed at the cold edge. A crew was actively pouring foundation wall along Line 0.8 and a number of column pads in area A had been poured earlier in the day.

#### **Division 04: Masonry**

04.01: 2024.09.03 – Masons were active at the elevator shaft, which was approaching the third floor. 04.02: 2024.09.17 – Elevator shaft masonry appeared complete. Scaffold erection at Stair S-1 was nearing completion.

#### Division 20-28: MEP

20-28.01: 2024.09.03 – Electrical conduit was being delivered to the site. At least one delivery had been made already.

20-28.02: 2024.09.03 – Underground plumbing was being installed in Area B. Sanitary out the south end of Area A had been installed into the parking lot.

20-28.03: 2024.09.17 – Electrical conduit had been installed through the parking lot.

#### **Division 32: Exterior Improvements**

32.01: 2024.09.03 – We were informed that piers at the bridge are set to start on 9/4. 32.02: 2024.09.17 – Piers at the bridge had been installed. Temporary access from Tuscanyview Drive had been established. Measures were in place across the stream to prevent spoils from going downstream. Bridge footing to start next week.
