

The Newport Board of Education held regular meeting on Wednesday, September 25, 2024, at 6:30 PM. The meeting was held at 30 W. 8th Street, Newport.

CALL TO ORDER

Chairman Ramona Malone asked for a roll call. The following were present: Ramona Malone, Aaron Sutherland, Tim Curl, & Ed Davis. Ms. Covington was absent this evening.

Ms. Malone asked everyone to stand and recite the Pledge of Allegiance and to pause for a Moment of Reflection. Ms. Malone read the mission statement.

Mr. Watts reported that the grand opening for the stadium was a success and gave a shout out to everyone who pulled the celebration together.

Data from the 2023-2024 School Report Card will be released under embargo at 1 p.m. ET on Tuesday, Oct. 1. The embargo will expire at 12:01 a.m. ET on Thursday, Oct. 3. The embargoed data and a media briefing packet will be available for members of the working press who request it.

Mr. Watts reviewed a handout on understanding Amendment 2 Public school district employees cannot advertise their opinions for or against the amendment during the workday. After hours, employees can voice their opinions as they see fit. Board members, since they are elected officials, can share information and opinions as they see fit. Private school are free to advocate for this amendment since they do not currently receive public funding.

Mr. Watts reviewed how the amendment will appear on the ballot for clarification. He reviewed legal exceptions if the amendment passes as well as related legislation and legal decisions over the last 8 years on the amendment. To allow public tax dollars to pay for private education, Amendment 2 proposes to create exceptions for seven different sections of KYs constitution.

- 1. Prohibits the legislature from passing laws targeting specific area(s) of state
- 2. Prohibits legislature from indirect enactment of laws targeting area(s) of state
- 3. Requires that taxes can only be collected for public purposes
- 4. Legislature is responsible for establishing efficient system of public schools
- 5. Common school fund prohibits taxation for funding of nonpublic schools
- 6. Education funding exclusively to be used to maintain state's public schools

7. Prohibits public education funds from being used for religious schools

If the amendment passes, lawmakers could allow the use of tax-payer funded vouchers for some families to pay for tuition, fees, etc. at private, religious, and home school programs. Education savings accounts allow taxpayer funds to be deposited directly into accounts designed to help some families pay for private school tuition, and fees. Scholarship tax credits will give donors tax credits for contributions to funds that cover tuition and other costs for some families to attend private and religious schools.

Mr. Davis asked if the amendment passes, can the funds cross state lines? Mr. Watts said the funding would be for KY schools only. Mr. Davis also commented on the phrase "may provide financial support for the education of students outside the system of commons schools" implying the word "may" lessens the impact of the language when in fact they do plan to use public tax money to fund this bill. Private schools are not required to operate under the same standards and/or rules as public schools which makes the bill even less desirable.

Ms. Payne shared her report asked for questions. Her report covered the key components of the district's literacy plan. She also provided a link for the board that compares fall to fall iReady data. The iReady data is an assessment that serves as a tool for understanding our students' academic starting points. The data collected gives insight into their current proficiency in reading and math and informs us of potential learning gaps, growth areas, and opportunities for targeted intervention.

Mr. Maines submitted his report and asked for questions/concerns. He also commented on the ribbon cutting ceremony and the grand opening event.

Ms. Swanson submitted her report. There were not guestions.
