**Recommendation/Motion:** Approve a revised BG-1 Project Application for the construction of the New Rise STEM Academy for Girls in the amount of \$59,103,400.65 (Fifty-nine Million, One Hundred Three Thousand, Four Hundred Dollars and Sixty-five Cents.)

**Background/Rationale:** A revised BG-1 Project Application for the bid/construction, identifying the extent and cost of the work, was approved by the Board at its August 26, 2024 meeting.
