Recommendation/Motion: Approve a revised BG-1 Project Application for the replacement of HVAC Systems at Booker T. Washington Elementary School in the amount of \$1,739,669.75 (One Million, Seven Hundred Thirty-nine Thousand, Six Hundred Sixty-nine Dollars and Seventy-five Cents.)

Background/Rationale: A revised BG-1 Project Application for the bid/construction, identifying the extent and cost of the work, was approved by the Board at its April 11, 2024 meeting.
