Thank you for considering Deco Architects, Inc. for Todd County Schools' architectural needs. From there we take and log detailed photographs for all of the major elements in KFICS.

The existing topography of the site helped to shape the overall program of the middle school by creating an opportunity to allow the students to physically ascend toward the high school as they move through 6th, 7th, and 8th grades. An open teaching area with built-in seating within the circulation area allows for impromptu interactions where students collaborate and teachers facilitate. Connecting meeting spaces to general circulation prompts broader sharing of ideas. Multipurpose spaces integrate presentation with practice, simulating performance in everyday experience.

The new Rockcastle County Middle School project focuses on the value of community. The design preserves the existing gymnasium that has served as a staple for community events for decades. PROJECT DESCRIPTION

This project expands Science Hill Elementary School's program with four standard classrooms equipped with state-approved furniture and learning equipment, two restrooms, a janitorial closet, and a mechanical room. To complement its spatial additions, the building's existing metal roof has undergone a visually striking replacement, now boasting a custom orange gutter system and black ribbed roof assembly. All design components adhere strictly to Kentucky Department of Education requirements and guidelines.

PROJECT DESCRIPTION

Deco worked with Pulaski County Schools to design and construct 23,000 square foot Health and Wellness Centers at each of their Middle School campuses. The Centers are programmed with a block of health offices, restrooms, a small fitness center on one end, an auxiliary gymnasium in the center of the building with an elevated walking track surrounding the gymnasium, and a stage on the other end of the building with a small back stage area. The Health and Wellness Centers service both staff and students and are utilized before, during, and after school hours. They are home to health offices for both district nursing staff as well as mental health professionals. The close proximity of a fitness center to the middle school and high school allows the schools to utilize the centers to disperse students during stacked gym classes, extra-curricular activities, guest speakers, events, sports practices, and other school functions. The district plans to also incorporate an arts initiative with the gyms offering spacious seating and the stages allowing schools to offer live performances and student dramas.
