### 6. ORDINANCES – 2<sup>nd</sup> READING

**6.A.** Ordinance 16-2024 entitled AN ORDINANCE CLOSING PORTIONS OF THE ALLEY RIGHTS-OF-WAY BETWEEN 512 WEST 9TH STREET, 915 CEDAR STREET, 917 CEDAR STREET, 919 CEDAR STREET AND 924 LOCUST STREET IN THE CITY OF OWENSBORO, KENTUCKY, was unanimously approved by a roll call vote; motion by Mayor Watson and a second from Mayor Pro Tem Castlen.

The City of Owensboro desires to close portions of the alley rights-of-way located between 512 West 9<sup>th</sup> Street, 915 Cedar Street, 917 Cedar Street, 919 Cedar Street and 924 Locust Street. The Petitioner and adjoining and/or abutting property owners agree to retain the public utility easements. City Manager Pagan explained this ordinance closes an alley between Cedar and Locust Streets, and south of Ninth Street behind Fire Station #1. The City has acquired four (4) properties behind the station to enlarge the site. As part of Operation Firehouse, the City is currently designing a new Station #1, and closing the alley will allow maximization of the site and reorient the station to front Ninth Street.

### 7. ORDINANCES - 1st READING

**7.A.** Ordinance 17-2024 entitled AN ORDINANCE CLOSING AN ALLEY RIGHT-OF-WAY BEHIND 1220 CENTER STREET RUNNING FROM EAST PARRISH AVENUE TO EAST 14TH STREET IN THE CITY OF OWENSBORO, KENTUCKY was introduced and publicly read on first reading.

Christ Community of Owensboro, Inc. has petitioned the City to close an alley right-of-way located behind 1220 Center Street running from East Parrish Avenue to East 14<sup>th</sup> Street. All adjoining and abutting property owners have provided written consent for the closure. Public utility easements will be retained. City Manager Pagan stated the alley closure is between East Parrish Avenue and East 14<sup>th</sup> Street. Christ Community Church initiated the closure and they own many of the properties along the alley. All other contiguous property owners have provided written consent for the closure.
