Out to inspect drain line for cause of blockage. The drain line servicing the locker room toilets has backed up and the plumbers removed what looked like mortar. We inspected the line and did not see and damage or instalation issues. We found what appears to possibly be a think layer of mortar buildup on the inside of the piping around the tie in of the locker room toilet nearest to the student parking area. When we flushed toilet paper it was able to begin to build up in this area. We suggest jetting the line to remove buildup which should deter solids from building up in the pipe.
