Item 01-01 (PCO#1R2 / RFI-001)

This change is for the additional time required to comply with OSHA regulations for demolition of additional Pyrobar material. Even though it is <1% asbestos content, abatement methods must be used for removal of the material and proper disposal. A separate purchase order for the labor cost of \$29,096.54 will be generated out of the abatement budget. While there is no cost change to this contract, a schedule increase of 21 days is required. Requested by General Contractor.

Cost Benefit to Owner: Required for safe removal of ACM material.

Item 01-02 (PCO#2 / ChgDir-04R1)

Provide material and labor to accommodate found condition of uneven / sloped floor surface in the area of Corridor #007, Office #008, Office #009, and Meeting #010. Doors were shifted around to accommodate the condition, resulting in planned electrical device locations being moved, all prior to initial installation. Requested by Architect.

Cost Benefit to Owner: Most cost effective solution for dealing with uneven / sloped floors not noticable in existing room configuration.

ADD: \$5,558.48

Item 01-03 (PCO-03R1 / RFI-008)

Provide material and labor to refeed existing dryer panel from existing switchboard and provide a new breaker. Requested by

Cost Benefit to Owner: Required to bring existing panel into code compliance. Existing feeder had no neutral wire.

ADD: \$12,136.21

Item 01-04 (PCO-04)

Provide (3) new breakers [(2) 3P 200A and (1) 3P 100A] at existing panel SB3. Requested by Engineer.

Cost Benefit to Owner: Required to replace existing breakers that will not disengage, eliminating hazard and making the circuits more serviceable.

ADD: \$3,521.90

Item 01-05 (PCO-05 / RFI-005)

Provide material and labor to completely remove embedded wood sleepers at Sr. Gym and fill the reveals that remain with concrete fill prior to installing bonding agent and placing the concrete topping. Requested by Architect and Engineer. Cost Benefit to Owner: Required to fill concealed voids in existing gymnasium concrete slab and improve the bond/performance of topping slab.

ADD: \$15,312.13

Item 01-06 (PCO-10)

Provide material and labor to add hot water supply to special needs washing machine as well as add code compliant venting to the waste line for the same location. Requested by Owner.

Cost Benefit to Owner: Adds much needed hot water to washing machine and venting ensures proper functionality. ADD: \$14,217.49
