

### Required Reporting School Report Card

Each school within the district has reviewed data contained within their school and district report card in addition to data upload and verification. School and district report cards provide information about assessment performance, teacher qualifications, student safety, and offerings within the schools. We are waiting on the new vendor to load the remaining data prior to publishing and a mid-November range has been communicated to us.

## **Continuous Improvement Planning**

Each school in the district has completed a Needs Assessment and School assurances. At the district level, needs assessment, district assurances, and the district safety report have been submitted.

# **Comparability Report**

On an annual basis KDE requires school districts to demonstrate comparability of services by first comparing student/staff ratios between non-Title I served and Title I served schools prior to the expenditure of Title I funds. Newport Independent schools are a single grade span. Newport Primary, Newport Intermediate, and Newport High School all served as school wide Title I programs.

# Title 1, Part D Child Count

The annual count is a survey that collects the number of students who are eligible for Title I, Part D funds from Kentucky.

Students must meet at least one of the following criteria:

- a. Must serve students who live in a residential facility for neglected or delinquent youth.
- b. Must have a residential facility for neglected or delinquent youth located within its boundaries
- c. Students who reside in the facility during the 30- day count period, aged 5 to 17 (upon entry to the facility) are eligible to be counted.

Newport Independent has submitted an approved Child Count. Due to an increase of 40 students over the prior year we have submitted an explanation to KDE that is due to the US Department of Education. Please note that Newport Regional is again serving an all male population of youth from across the state.

# **Performance Report**

Newport Regional has submitted an approved Performance Report. The purpose of the report is to collect program data that the US Department of Education uses to demonstrate effectiveness of Part D, Title I.
