KSA is one measure of student performance. We utilize KSA, along with projects, personalized learning opportunities, district data, and classroom assessments to get a complete picture of student learning and student performance.

We believe that student well-being, social-emotional learning, and mental health are equally as important to academic performance.

Allen County Schools take a whole-child approach to serving our students by providing academic, social-emotional, and mental health supports to all students. In addition to an academic focus to improve student performance, we also provide daily social-emotional learning, and mental health support.

Overview of KSA



- The Kentucky Summative Assessment (KSA) is given annually in the spring of each year in grades
 3-8, 10, and 11.
- Measure proficiency and progress on state content standards.
- Includes multiple choice, critical thinking, problem solving, constructed response, and technology-enhanced response.
- Reading and Math is given in grades 3-8, and 10.
- Science is given in grades 4, 7, 11.
- On-demand writing, editing, and mechanics are given in grades 5, 8, 11.
- Social Studies is given in grades 5, 7, 11.
- Each school receives data approximately one month prior to public release.
- Reports are sent to each parent/student.





This assessment is not your typical multiple choice assessment, where you fill in the bubble of the correct answer. The navigation of the system (next arrow, using the calculator, drag and drop, typing, etc.) are all things students have to do - beyond knowing the content.

Our teachers have all been through the practice assessment to see what all our students have to do to successful take the assessment.

Overall Performance Rating Colors

The Overall Performance Rating for elementary, middle and high schools is reported using a color rating system to communicate performance of schools. Color ratings include five performance levels (red, orange, yellow, green, blue), with red being the lowest rating and blue being the highest rating.

What do the colors mean on KSA?

The overall performance rating is determined by state indicators that combine current year performance, "Status" and improvement from the prior year, "Change." Cut scores for Status and Change Levels are based on a distribution and were approved by KDE and LSAC (Local Superintendent Advisory Council).
