Agreement Between  
Christian County Board of Education and  
Dyslexia Association of the Pennyrile

This agreement, made and entered into this date, to be effective July 1, 2024 until the end of June 30, 2025 as agreed upon by and between Christian County Board of Education, 200 Glass Avenue, Hopkinsville, KY 42240, hereinafter referred to as CCBOE and Dyslexia Association of the Pennyrile, 538 Noel Avenue Hopkinsville, KY 42240, hereinafter referred to as Dyslexia Association of the Pennyrile.

BOTH PARTIES AGREE AS FOLLOWS:

1. Dyslexia Association of the Pennyrile will provide one or more of the following services at the direction of the CCBOE:
  - a. Provide access to the Barton Reading and Spelling System, an Orton Gillingham influenced multisensory structured, explicit and systematic phonics system at the cost of \$100 per student per school year.
  - b. Assist in the purchasing of additional materials to be used with the system with CCBOE covering the cost of the materials.
  - c. Direct coaching and support as requested by CCPS
  - d. Staff training to be paid by the CCBOE at an agreed upon price by the Dyslexia Association of the Pennyrile and CCBOE prior to the training.
2. Dyslexia Association of the Pennyrile shall hold harmless the CCBOE for any injuries to third parties resulting from discharging the provisions of this contract. Dyslexia Association of the Pennyrile shall insure all educational and other records, either received from CCBOE or formulated during the school year will remain confidential.

3. CCBOE shall designate a liaison between Dyslexia Association of the Pennyrile and the CCBOE as well as appropriate staff to deliver reading tutoring services to Christian County Public School students.
4. Any part of this Agreement may be amended by mutually agreeable written signed consent by both parties without affecting the unchanged portion thereof.
5. Either party shall have the right to terminate and cancel this agreement at any time by providing thirty (30) day written notice to either party, given good cause.
