

**MEMORANDUM OF AGREEMENT
Between
Jefferson County Board of Education
And
The Lou Tate Foundation, Inc.**

This Memorandum of Agreement (hereinafter "Agreement") is entered into between the Jefferson County Board of Education (hereinafter "JCPS"), a political subdivision of the Commonwealth of Kentucky, with its principal place of business at 3332 Newburg Road, Louisville, Kentucky 40218 and the Lou Tate Foundation, Inc dba The Little Loomhouse. (hereinafter "FOUNDATION"), a Kentucky non-profit in good standing located at 328 Kenwood Hill Road Louisville, KY 40214.

WHEREAS, the FOUNDATION supports the work of the Little Loomhouse, which is a fiber arts education organization whose mission is to continue the legacy of founder Lou Tate, a master weaver, by education students of all ages about the history of weaving and textile arts through diverse programs, residencies, and community partnerships;

WHEREAS, the FOUNDATION working through the Little Loomhouse will collaborate with the Teachers at JCPS schools to provide an arts residency at interested school;

WHEREAS, JCPS desires to partner with the FOUNDATION to provide the residencies;

NOW THEREFORE, in consideration of the terms, conditions, premises, and mutual agreements set forth herein, JCPS and the FOUNDATION agree as follows:

1. Duties of the FOUNDATION:

- a. Little Loomhouse staff and/or volunteers will provide programming under the supervision of the school's Art or other Teacher. Attachment A is the price list for workshops and artist residencies. Little Loomhouse may utilize available grant funds are available to cover all or part of the costs for a workshop.
- b. Not use the name or logo of JCPS or individual JCPS schools in printed materials, websites, videos or social media without prior approval from JCPS.
- c. For any projects involving program evaluation, monitoring activities, or data collection or research of any kind, JCPS student or staff participation is voluntary. As a federally authorized Institutional Review Board (IRB), JCPS complies with the federal definition for research, which includes sharing of Personally Identifiable Information (PII) for the purpose of answering a question or evaluating activities for effectiveness beyond standard educational or operational procedures. Thus, all research, program evaluation and data collection activities must be approved by the JCPS IRB and shall not begin before approval is secured from the JCPS IRB.

- d. If the performance of this Agreement involves the transfer by JCPS to FOUNDATION of any data regarding any student, FOUNDATION acknowledges the data shared by JCPS is confidential data and proprietary to JCPS, and it agrees to protect the data from unauthorized disclosures and to comply with all applicable JCPS, Local, State and Federal confidentiality laws and regulations including but not limited to the Family Education Rights and Privacy Act, 20 U.S.C. 1232 (g) and 34 C.F.R. 99.31 (a) (6) (“FERPA”); the Privacy Act of 1974, 5 U.S.C. 552a; the Kentucky Family Educational Rights and Privacy Act, KRS 160.700 et seq.; the Richard B. Russell National School Lunch Act, 42 U.S.C. 1751 et seq.; the Child Nutrition Act of 1966, 42 U.S.C. 1771 et seq.; the Personal Information Security and Breach Investigation Procedures and Practices Act, KRS 61.931 et seq.; and the Kentucky Open Records Act, KRS 61.820 et seq.
- e. If the performance of this Agreement involves the transfer by JCPS to FOUNDATION of any data regarding any student that is subject to FERPA, FOUNDATION agrees to:
1. Use any such data for no purpose other than to fulfill the purposes of this Agreement, and not share any such data with any person or entity other than FOUNDATION and its employees, contractors, volunteers, and agents, without prior approval of JCPS. Disclosure shall be limited to only those employees, contractors, volunteers, or agents who are necessary for the fulfillment of this Agreement.
 2. Require all employees, contractors, volunteers, and agents of FOUNDATION to comply with all applicable provisions of FERPA with respect to any such data. FOUNDATION shall require and maintain confidentiality Agreements with each employee, contractor, volunteer, or agent with access to data pursuant to this Agreement.
 3. Maintain any such data in a secure environment, whether physical or electronic, and not copy, reproduce, or transmit any such data except as necessary to fulfill the purposes of this Agreement. FOUNDATION shall notify JCPS within 24 hours in the event of any data breach or disclosure of data to any person or entity other than the parties listed in this agreement.
 4. Collect, store, and maintain data in a manner that does not permit the identification of an individual student by anyone other than employees, contractors, or agents of FOUNDATION necessary for the fulfillment of this Agreement and having a legitimate interest related to the purposes of this Agreement in knowing such personal identification, and not disclose any such data in a manner that would permit the identification of an individual student in any form, including, but not limited to, published results of studies.
 5. Destroy or return to JCPS any such data obtained under this Agreement within thirty days (30) after the date by which FOUNDATION no longer needs it for the purposes of this Agreement. FOUNDATION will require all

employees, contractors, volunteers, or agents of any kind to comply with this provision.

- f. JCPS retains the right to audit FOUNDATION's compliance with the confidentiality requirements of this provision. FOUNDATION acknowledges that any violation of this Agreement and/or the provisions of FERPA or accompanying regulations related to the nondisclosure of protected student information constitutes just cause for JCPS to immediately terminate this Agreement pursuant to Article 5 of this Agreement.
- g. Maintain an all-risk property and casualty insurance policy with respect to the facilities and a policy of commercial general liability in amounts no less than \$1,000,000/\$2,000,000 per policy and provide JCPS with a certificate of insurance upon request.
- h. Require all FOUNDATION employees/interns/volunteers/contractors performing services under this Agreement to have on file a Criminal Records Check, per Kentucky law and JCPS requirements, completed no more than five years ago. Employees/contractors convicted of any of the following, per JCPS Board Policy 03.6, shall not be considered:
 - 1. Any conviction for sex-related offenses.
 - 2. Any conviction for offenses against minors.
 - 3. Any conviction for felony offenses, except as provided below.
 - 4. Any conviction for deadly weapon-related offenses.
 - 5. Any conviction for drug-related offenses, including felony drug offenses, within the past seven years.
 - 6. Any conviction for violent, abusive, threatening or harassment related offenses.
 - 7. Other convictions determined by the Superintendent/designee to bear a reasonable relationship to the ability to perform services under this Agreement.
- i. All FOUNDATION employees, interns, volunteers and contractors under this Agreement shall immediately notify the Principal or the Volunteer Talent Center if they are convicted of or plead guilty to one of the criminal offenses listed above, and shall immediately cease providing services under this agreement and shall not remain upon premises of a JCPS facility for any purpose under this Agreement.
- j. FOUNDATION shall require all employees/interns/volunteers/contractors performing services on JCPS school premises during JCPS school hours under this Agreement to submit per KRS 160.380 to a national and state criminal history

background check by the Department of Kentucky State Police and the Federal Bureau of Investigation and have a letter, provided by the individual, from The Cabinet for Health and Family Services stating no findings of substantiated child abuse and neglect records maintained by the Cabinet for Health and Family Services.

- k. FOUNDATION staff and volunteers will comply with all JCPS health safety guidelines including rules related to COVID-19 mitigation.
- l. To the extent that JCPS facilities are closed to students, those facilities will also be unavailable to FOUNDATION. During any periods of the Non-Traditional Instruction (NTI) or remote learning, JCPS facilities will not be available to FOUNDATION.

2. Duties of JCPS:

- a. School who schedule workshops under this Agreement will pay The Foundation in accordance with the price list attached, unless The Foundation agrees to cover some or all of the cost of the particular workshop using available grant funding.

3. Mutual Duties:

- a. Each party shall comply with the Title VI of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, the Kentucky Equal Employment Act of 1978, KRS 45.550-45.640, and the American Disabilities Act, and shall not discriminate against any JCPS employee, student or student's parent or guardian based on race, color, national origin, age, religion, marital or parental status, political affiliations or beliefs, sex, sexual orientation, gender identity, gender expression, veteran status, genetic information, disability, or limitations related to pregnancy, childbirth, or related medical conditions.
- b. Each party shall comply with all federal and state laws and regulations and all JCPS policies applicable to the provision of the services described in this Agreement, including without limitation the Federal Family Educational Rights and Privacy Act (FERPA), the Kentucky Educational Rights and Privacy Act (KFERPA), the federal Health Insurance Portability and Accountability Act (HIPAA) and JCPS policies and procedures for volunteers and visitors entering JCPS facilities.
- c. The respective administrative offices of JCPS and FOUNDATION who have responsibility for the implementation of this Agreement shall meet periodically during the term of this Agreement to evaluate the program and discuss issues of mutual concern.

- 4. **Term:** This Agreement shall be effective commencing December 18, 2024 and shall terminate on December 31, 2025. The Agreement may be extended by mutual written agreement of JCPS and FOUNDATION.


5. **Termination:** Either party may terminate this Agreement prior to the end of its term by giving thirty (30) days prior written notice to the other party. If JCPS terminates the Agreement, FOUNDATION will be permitted in their discretion to continue to provide services during the period in which the thirty (30) day notice becomes effective.
6. **Amendment:** This Agreement may be modified or amended only by a written agreement signed by JCPS and FOUNDATION.
7. **Independent Parties:** JCPS and FOUNDATION are independent parties, and neither shall be construed to be an agent or representative of the other, and therefore neither shall be liable for the acts or omissions of the other. Each party shall, however, be liable for any negligent or wrongful acts of its own employees, students and invitees.
8. **Captions:** Section titles or captions in this Agreement are inserted as a matter of convenience and reference, and in no way define, limit, extend, or describe the scope of this Agreement.
9. **Entire Agreement:** This Agreement contains the entire agreement between JCPS and FOUNDATION concerning the FOUNDATION and supersedes all prior agreements, either written or oral, regarding the same subject matter.
10. **Severability:** If a court of competent jurisdiction holds any provision of this Agreement unenforceable, such provision shall be modified to the extent required to make it enforceable, consistent with the spirit and intent of this Agreement. If such a provision cannot be so modified, the provision shall be deemed separable from the remaining provisions of this Agreement and shall not affect any other provision.
11. **Counterparts:** This Agreement may be executed in counterparts, in which case each executed counterpart shall be deemed an original, and all executed counterparts shall constitute one and the same instrument.
12. **Applicable Law:** This Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Kentucky.

We can customize a workshop to meet your group's needs, up to 30 students at a time. Lessons are designed to be 50 minutes in length. Rates include materials.

Fiber & Spinning



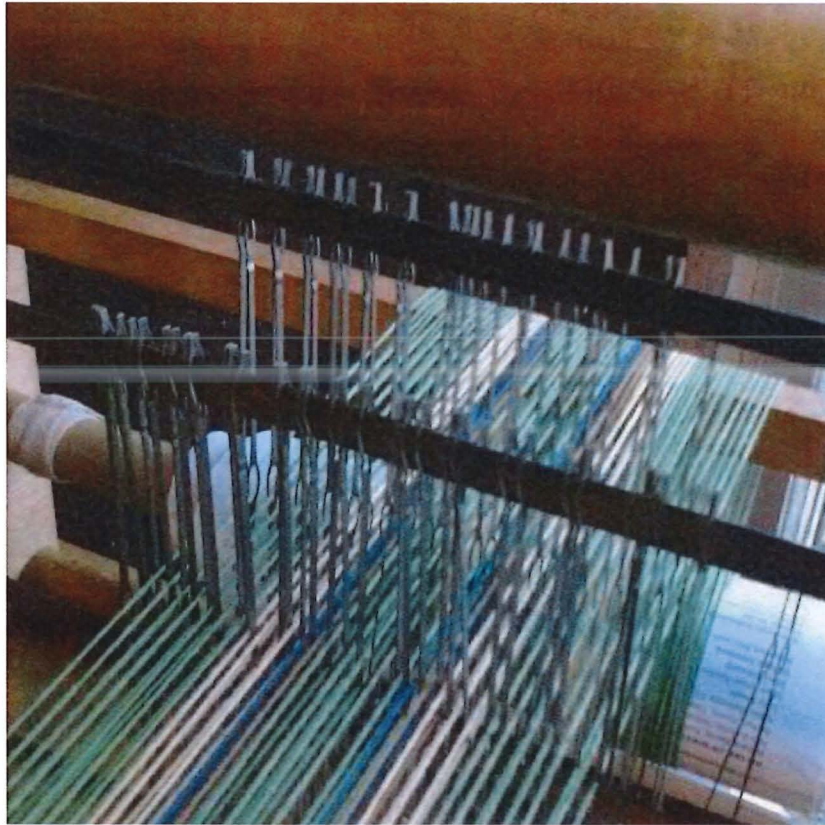
K-12th Grades and Adult Programs

1 Class period (50 mins)

\$200

Students will be introduced to different types of fiber and their uses, how wool is spun into yarn and how to ply yarn. Students take home a small amount of spun wool and friendship bracelet.

Loom Weaving



1st-12th Grades and Adult Programs

3-4 class periods (1st – 2nd grade) 3 class periods (3rd-12th grade)

\$600 – \$800

Students will weave on individual lap looms while rotating turns onto a Lou Tate Little Loom. Students will finish individual pieces for take-home and a group piece will be cut from little loom for classroom display.

Loom Weaving and Fiber Spinning



1st-12th Grades

4-5 class periods (1st-2nd grade)

4 class periods (3rd-12th grade)

\$800-\$1,000

This is a comprehensive program on fiber, from raw wool to woven piece. Students will take home a small amount of spun wool, woven pieces, and a group piece will be done on the Little Loom for classroom display

Kentucky Coverlet



4th – 12th Grades and Adult Programs

3 class periods

\$600

Students will learn about the history and folk art tradition of weaving coverlets. Students will weave their own miniature coverlet to take home.

Dream Weavers or Weaving in the Round



1st-12th Grades and Adult Programs

1-2 class periods

\$200-\$400

Students will be introduced to the art of Weaving in the Round.

Students will design and weave their own pieces to take home.



Navajo Rug

1st-5th Grades

3 class periods

\$600

Students will learn about Navajo weaving traditions and will design and weave a miniature Navajo rug.



Quilt Designs

3rd-12th grades, 3 class periods, \$600

Students learn about and use traditional quilt patterns to practice design and color theory, while creating colorful bandanas using basic measurement tools and fabric dye markers.

Stitching Animals

2nd-12th grades, 3-4 class periods, \$600-\$800

The art of embroidery will be introduced from different cultures. Students will learn basic embroidery techniques, design and stitch their own animal or landscape. Elementary-Middle will explore stitching on burlap with yarn; High school on up will explore using cotton and embroidery floss.



Visiting Artist for the Day

K-12th Grades and Adult Programs

2-6 hours for rotating classes or fair or festivals. All bookings, including non-profit fairs and festivals, must be paid.

\$400-\$1200

Bring a Little Loomhouse Artist to your School for the day. The perfect fit for Pioneer Day, Harvest Homecoming, or School Assembly. Demonstration includes an introduction to different types of fiber, how to spin wool into yarn, and weaving on the Little Loom.


