1. Opening Business
  - a. Approval of the Agenda
    - i. Motion to approve the agenda made by Mr. Fitzgerald, second by Mr. Ratterman. No objections.
  - b. Approval of the September Minutes

  - b. Good News Report
    - i. Mr. Meyers commented on our positive attendance rates. As a district, our attendance rate is up 2.63% compared to this time last year.

2. Student Achievement Report/Data
  - a. Post-Secondary Rate
    - i. There has been no change in our current Post-secondary Readiness. The school did administer the KYOTE last week to offer sophomore students an opportunity to gain the needed scores to attend the Young Scholars Association at NKU.
    - ii. Mrs. Kohrs shared how some of our students who attend The Point will become Career Ready due to the School to Work Program.
  - b. KSA Data Review
    - i. Mr. Meyers shared the KSA report that he shared with the Board at the special data meeting last week. He specifically pointed out our accountability scores for the middle and high school and how we compare

with other local schools. He also pointed out a few specific areas of growth and struggle.

  - a. Mrs. Kohrs outlined the course failures of our special education students for the first quarter. The only concerning number was from the sophomore group who had five students failing nine courses.
