Kentucky girls lacrosse coaches association is now made up of all member schools in the state of KY.

We have two regional representatives for each region that are present for coaches meetings and voting purposes and considered voting members of the association.

The meeting that was held Dec 29 when RPI was discussed and suggested was represented by all 8 regions. 4 reps were not present but each region was represented at the meeting when the vote was taken.

Region 1: Both reps voted yes for RPI (South Warren and Greenwood)

Region 2: 1 rep voted yes for RPI (Mercy) 1 rep voted no for RPI (Manual)

Region 3: Both reps voted yes for RPI (Collegiate and Sacred Heart)

Region 4: Both reps voted yes for RPI (KCD and Eastern)

Region 5: Only one rep was present and voted no for RPI (Ryle)

Region 6: Only one rep was present and voted yes for RPI (South Oldham)

Region 7: Only one rep was present and voted yes for RPI (Sayre)

Region 8: Only one rep was present and voted yes for RPI (Lafayette)

So of each 8 regions represented each region voted yes on post season RPI other than region 6 whose one rep voted no.

The entire state represented made it evident that a post season RPI was not only the most fair but also not an issue for travel or inconvenience and allowed for the most competitive and engaging state tournaments possible moving forward.
