- 4. PRESENTATIONS
- **4.A.** City Manager Pagan explained that the City was contacted by Owensboro Times (OT) and proposed a snowplow naming contest. Ultimately, the public would have an opportunity to submit names for the City's snowplow fleet. John Kirkpatrick, Assistant Editor at OT, said that the winners were chosen based on submissions that were unique to Owensboro related to local landmarks, beloved local businesses and iconic community names. A video was played that depicted snowplow drivers announcing the winning names: Snowowensboro Times, Old Slickory, Brr-goo, The Big Drifter, Winter Whip and Edward Blizzard Hands.
- **4.B.** Jason Hayden, Director of Owensboro Museum of Fine Art (OMFA), introduced himself and gave a brief update on the OMFA. The museum has 4,000 pieces in their permanent collection and they are expanding their education outreach. He introduced two new staff members, Colin Davis (Development Team) and Rebecca Stoen (Director of Education). Mr. Hayden thanked the City for their continued support.
- **4.C.** Owensboro Sister Cities and Regions (OSCAR) Board Member, Chief James Howard, gave a brief history of the organization (presentation attached). The City currently has two sister cities, Nisshin, Japan and Olomouc, Czech Republic. In 2024, Olomouc hosted two Owensboro-Daviess County firefighter exchanges that consisted of a planning delegation and a training delegation. Board President, Michael Vanover, discussed their new Ambassador Program and future school and choir exchanges, to include a reciprocal firefighter exchange. There was brief discussion on WKU having their own exchange program and the possibility of revitalizing the Nisshin relationship.

- **4.D.** Mayor Watson recognized the retirement of Sandy Payne, Telecommunicator, as she retires after 25 years.
- **4.E.** The City Project List was distributed and City Manager Pagan noted that repurposing the tennis courts at Dugan Best was added to the list (attached). Amanda Rogers, Parks Director, stated that the courts were at the end of their life cycle, and since they are underutilized, city staff wanted to seek input for alternate uses. Using the master plan as a guide, staff sought input at a public meeting and they asked the Dugan Best Recreation Center users for suggested uses. These efforts resulted in five proposed purposes: street soccer, youth basketball (9' height rim instead of 10'), GaGa Ball pit, obstacle course, general play space to include hopscotch, 4 square, and small open asphalt space. The plan is to add a batting cage near the ball field next year when the fencing is due to be replaced. Mrs. Rogers added that they are also planning to renovate the basketball courts at Moreland Park into two pickleball courts.

6. ORDINANCES - 1st READING

6.A. Ordinance 1-2025 entitled AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025, AND AMENDING ORDINANCE 7-2024 TO PROVIDE APPROPRIATIONS FOR LAND PURCHASE, TRANSFER FUNDS FOR ARPA AND CAPITAL PROJECTS, AND TO RECEIVE AND APPROPRIATE GRANT FUNDS was introduced and publicly read on first reading.

Budget amendment to provide appropriations for land purchase, transfer funds for ARPA and capital projects, and to receive and appropriate grant funds. City Manager Pagan explained that the second budget amendment for the current fiscal year contains: various grant applications that were approved in previous meetings, now require the revenue and expenditure of grant funds be added to the budget; funds to purchase the Veterans Boulevard property previously approved; and the transfer of funds for the indoor sports facility, so all funding is in the same place. There is nothing new in the amendment, it's primarily to account for the expense/revenue associated with various projects or initiatives already approved.
