DISCUSSION

November 18, 2024 the Board approved the construction documents for the BHS/OCHS Improvements project.

On January 21, 2025, bids for the project were received, opened, and read aloud for the above referenced project. Two (2) contractors submitted a lump sum bid. The lowest and best bid submitted, complying with the plans and specifications, was received from Marrillia Design and Construction in the base bid amount of \$38,600,000.00. (Refer to the attached bid tabulation.) Three Alternates were included and have been reviewed by the Design Team. Alternate No.1 for Roof Mounted Photovoltaics (add of \$1,689,636.00), Alternate No.2 for Medium Voltage Service (add of \$1,573,929.00) and Alternate No.3 for Owner Preferred Hardware (no cost change).

After thorough review by Studio Kremer Architects and Brent Bohannon, Director of Facilities Management, it is the recommendation that the contract be awarded to Marrillia Design and Construction, 794 Manchester Street, Lexington, KY 40508 for the lump sum amount of \$40,173,929.00. Including the low base bid and accepting alternates bids No. 2 & No. 3.

On January 21, 2025, two (2) bids were received for the above referenced project. Marrillia Design and Construction of Lexington, Kentucky submitted the low Base Bid amount of Thirty Eight Million Six Hundred Thousand dollars and no cents (\$38,600,000,00).

After the Bids were opened, the Design Team began the review of the Unit Prices and additional clarifications have been requested from Marrillia Design and Construction. Once this review is complete and agreed upon, the list of acceptable Unit Prices will be attached to a Contract for construction. The subcontractor and manufacturer lists were reviewed, references contacted, and with modifications are found to be acceptable. 

Mr. Bohannon,

CMTA has completed its review of the bids submitted January 21, 2025, for the above referenced project, specifically Alternates #1 and #2.

The bid for Alternate #1 for providing photovoltaics (solar) on the roof of the new structure came in at \$1,689,636. This is proportionate to other projects when compared by \$/W of installed solar production. Based on past utility bills, this solar array would generate approximately \$76K in savings for the district's general fund.

The bid for Alternate #2 for providing Medium Voltage Gear came in at \$1,573,929, comparable to other medium voltage projects of similar size. Using past utility bills, it was determined that the Alternate #1 would save approximately \$168K per year in utility bills, which are paid through general funds, by eventually combining eleven meters on the Buckner campus into one service. This saving is provided by combining multiple demand based electrical meters into one service for the whole Buckner campus, resulting in a lower \$/kWh rate.

It should be noted that the base bid includes heating and cooling to be provided through a geothermal wellfield. The current Inflation Reduction Act legislation allows for non-taxable entities, such as Oldham County Schools, to benefit financially from installing sustainable energy solutions in the form of a direct payment from the federal government. The geothermal design of BHS/OCHS Gym allows Oldham County Schools to receive 30% back on geothermal related costs as a direct payment check after substantial completion of approximately \$1.4M, this would cover 92% of the cost for Alternate #2. The installation of solar would also take advantage of this same legislation, resulting in an additional \$506K back to the district.

The acceptance of both add-alternates results in an estimated \$7,150,000 savings for OCS over the next 30 years. It is CMTA's recommendation that both alternates be accepted to fully recognize the benefits of our design.
