Championship and Competition Rules Information and Discussion

Reviewed State Soccer Scheduling and Site Alternatives

The Commissioner and staff briefed the board on potential changes to the championship calendar as well as options for the state finals site.

Reviewed Feedback Around State Soccer Bracketing

The Commissioner and Staff reviewed and discussed situations around the state soccer state bracketing and possible alternatives. No action was proposed at this meeting.

Approved Changes in Region 6 and 7 Basketball Alignment Following Evangel Christian Clarification

The Commissioner and staff reviewed the follow-up data related to Evangel Christian and other potential moves in the basketball alignment as discussed in November. The Commissioner and staff have been working with the representatives of the Board of Control, Jefferson County and Bullitt County schools for more than a year on basketball alignment. There was no discussion of schools coming and going from the collective 6th and 7th region schools, but much discussion about moving around within the districts in those two regions.

Since the alignment was adopted in the mid-2000s, several schools have relocated to new facilities as well as at least two schools being opened in that time. Other construction projects and moves are ongoing.

Working with the board members from that area and the Commissioner, the schools attempted for more than a year to reach consensus on a change in alignment. The Association provided a basis for a minimally invasive couple of changes that would at least align schools that had new facilities in more appropriate locations. From that, the committee held several meetings in an attempt to address the issues on a deeper level.

As is usual in these cases, when dots were placed on a map, there was a good deal of consensus on groupings, however when specific names and programs were labeled, discussion took on a different tone.

One difference in this area than most any other area of the state is the need to be concerned about placement of the single gender schools in the area. Placing them, without at least considering grouping them, can lead to issues in postseason play and significant differences in bracket sizes and scheduling issues.

In the end, this committee was unable to reach consensus and deferred to the Association for any changes. In light of the many coming changes in the next couple of years, the best course seems to be to simply address the geographic issues, and continue to work on a more comprehensive factual basis can be used as facilities are completed.

The remaining concern point right now is Evangel Christian is reportedly completing a new facility in a different area of the county (near Billtown Road at Snyder), but until that is complete, the movement should likely be delayed.

The Board previously addressed the other situations in November.

None of these fixes addressed a key issue in that area, and that is disparate participation in some of the other sports offered that generally match the basketball alignment. That would require a much more comprehensive review and likely be much more complex if geographic principles are to be honored.

Approval of Contract for Heat/Air Control System

The Commissioner and staff detailed the current situation. For nearly all of its 33 years in this location, heating and air has been a continual expense. Two years ago, the Board of Control approved the use of Titan Building Solutions as the new vendor solution. This company does many large facilities in Lexington, including such challenging projects as the "Blue Building" downtown.

They have worked on projects large and small. This project, which could be completed in and around the latter part of March, would finally allow for centralized control of the air flow and mechanical systems at the office. With the recent replacement of the rooftop units, this change would allow for complete control and regulation, and undoubtedly lead to lower costs and higher efficiency.

The results of their study and recommendation are attached, and this is the first time that the Association has clearly had the funds to undertake this project. Comparative proposals in the industry show that this proposal is at or slightly cheaper than others in the market, and they will have the advantage of having done the early review to be sure it will work.

Consider Formal Approval of Adopted Format for Postseason Lacrosse

Following the distribution of the board action in November, there was a small amount of, but fairly united feedback, about the qualifying teams for postseason. Despite the

relatively few numbers, it was the consensus of nearly everyone that provided feedback that the runners-up in each region should also advance to the state tournament.

This would permit lacrosse to use the same format as boys' volleyball.

There was also feedback about bracketing. In some cases, this came from regions where schools that traditionally have been stronger, might be paired together in early rounds, rather than late. This is not unlike many other sports and championships. The suggestion from a coaches' association group (attached) was that the RPI be used for the entire tournament bracket.

Due to the now statewide nature of the sport, staff feels strongly that until there is more data available to show the results of the true statewide championship, this change should not be made. It was staff's original recommendation that the final four be seeded via RPI, but the Board discussion led to a blind draw format for both tournaments after the paired-region based first two rounds. The discussion then was to monitor the championships for the first couple of years before making changes.
