History/Background:

February 28, 2022

Board approved Initial BG-1 (Order# 19999).

July 25, 2022

Board approved Bid Package #1 for Dixie Roofing Inc in the amount of \$2,015,265 (Order#20086).

September 25, 2023

Board approved Bid documents and to advertise for bids (Order# 20390).

October 17, 2023

Bids were accepted by RossTarrant and opened at 2:00 pm with one (1) bid being received by Spray Foam Technologies of KY in the amount of \$3,120,000.00. The bid was over budget and after discussion with the Superintendent the decision was made to rebid the project and do the exterior only due to funding.

November 27, 2023

Bid Package #2 was awarded to Dixie Roofing Inc in the amount of \$2,235,100.00. (Order# 20411).

December 18, 2023

Board approved revised BG-1. This revision was a fund source change only for the contingency funds to be allocated to the general fund instead of ARP Esser (Order# 20424).

March 24, 2025

This revision is due to a change in the contingency of \$16,350.17 to allow that amount to be allocated to ARP Esser funds instead of General Fund. Once this is approved a BG5 can be completed to close out the project.
