

Attendance By School & Grade Attendance Month 5

Title I

ESSA requires a district to annually offer equitable participation in Title I, Part A services to each private school that has children from participating Title I, Part A attendance areas. Private schools located within or outside the district are eligible to receive services. Home schools are treated as private schools in Kentucky. Title I, Part A provides services to eligible private school children, not funds to private schools per ESSA 1117(d). Once we have established the participating public school attendance areas we then determine the number of children from low-income families residing in each participating public school attendance area who attend public schools and private schools.

In the spring of each year, the Title I Coordinator contacts officials from every private and home school serving students in or through our attendance area. This notification includes a participation survey for the upcoming fiscal year.

For the upcoming year 35 students were identified as qualifying for free or reduced lunch via the private schools household income form. As of March 17, 2025 five private schools have indicated an intent to participate in Title I representing 24 students that are generating funds.

Based on FY 25 this will equate roughly to \$30,000 reserved for private schools for instructional and professional learning as well as parent and family engagement. Once we receive an initial allocation in late summer 2025 we will finalize the total budget.

The next step in the process will be meeting with representatives of the private schools for consultation. ESSA 1117(b) requires that we provide "timely and meaningful consultation" to eligible private schools that elect to receive services.

Title III

The English Learner extract report has been reviewed and there were no errors. KDE pulls this report from our Infinite Campus during the month of March each year. This report provides a list of students with English Learner status who have at least one instructional accommodation and at least one EL service type during our instructional year. This report also includes those students with an EL exit status. We have 181 total students with an enrollment percentage of 157.4 (based on the amount of days enrolled). This information is used to determine Title III needs as well as EL add on to SEEK.

Lau Plan

All districts are required to develop a local plan to meet all English Learner requirements. This plan is named from the Supreme Court case, Lau vs. Nichols 1974 and examined federally funded schools and supplementary EL programs for non-English speaking students. We will be meeting in April and plan to bring this to the Board prior to our submission.
