

Commissioner's Report – March 2025 Kentucky Board of Education

Furthering Kentucky's United We Learn vision and advocating the importance of a transformed educational experience for every student in the Commonwealth is one of my top priorities as commissioner. The United We Learn Vision aims to provide a reimagined assessment and accountability system that includes vibrant learning, making it meaningful and useful for all learners. Kentucky Department of Education (KDE) members and I have listened to stakeholders across Kentucky and responded to their calls for action with the development of new approaches to assessment and accountability. Ongoing feedback and guidance from broadreaching stakeholders via meetings, surveys, focus groups, and, most recently, town hall meetings, have informed the development of a framework that may serve as a starting point for discussions with the General Assembly for consideration of legislative changes.

The journey to the latest assessment and accountability framework model has been built on inclusion, empathy, reciprocity and co-creation, as outlined in the Kentucky Board of Education's (KBE's) 2023 <u>A Call to Action</u>. As we continue to advocate for a reimagined assessment and accountability system, I want to thank the many stakeholders who have co-created this work and expressed their goals, aspirations, and feedback in meaningful ways. This inclusive design process truly is helping bring about a bold new era of education in Kentucky.

I also want to highlight Kentucky's first statewide Agriculture Education Week, March 17-21, as an example of the "All In" approach to creating vibrant learning opportunities for students, innovation, and collaboration with our communities related to the diverse world of agriculture. This exciting new collaboration between the Kentucky Department of Agriculture, KDE and Team Kentucky was designed to broaden access to ag education and was so successful



that we are already planning the next "All In for Ag Week" for Sept. 15-19, 2025.

Lastly, given recent announcements at the federal level related to the U.S. Department of Education (ED), I want to assure the Kentucky Board of Education that I, along with department staff, remain committed to our Commonwealth's students and am confident in our ability to assist districts in providing an excellent education, filled with vibrant learning experiences. It is my hope that these changes will have a minimal impact on our schools, and more importantly, on our students. We will await and share with the board any additional information we receive on how ED Secretary Linda McMahon proposes ED's closure as permitted by law.



Wayne County Area Technology Center (WC ATC)

Jun 21, 2024- The Wayne County Board of Education unanimously approved funding for the Wayne County Area Technology Center (WC ATC) Special Education part-time positions as a result of a successful pilot year in 2023-24.

The board approved a \$30,000 contribution towards student achievement for students enrolled at the ATC. At the start of



the past school year, there were 22 students failing classes offered at the ATC building. Once, the three retired teachers were hired to assist students as resource teachers who provided extra support; zero students were identified as failing on the last assessment. The program provided the recent summer Work Boot Camp a virtual reality promotional program to attract younger students to the ATC, and mainly intervention services during the entire school year.

The pilot project grant totaled \$140,000 this past year and WC ATC was one of four participating schools who took advantage of this grant opportunity.

WC ATC Principal John Kennett noted, "This program helped our kids tremendously." He praised his teacher's efforts to promote student success through this grant.

He was efficient on who he chose to implement this program, so he did not have to take any existing teachers out of the classroom. Fortunately, retired teachers Noel Vaughn, Jason Kennett and Micha Hicks agreed to accept the part-time positions.
