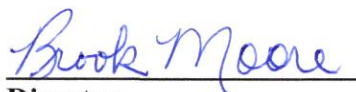

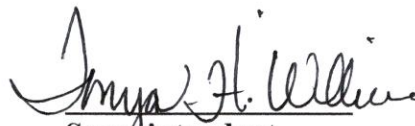

Dear Dr. Fletcher:

The Floyd County Board of Education is requesting an emergency day wavier per 702 KAR 7:140, Section 4 (3). As of today's date, Floyd County Schools have missed a total of thirty days, twenty weather related and ten non-instructional days (also due to weather).

At this time, we are requesting an emergency day wavier for the following:

Duff-Allen Central Elementary: One additional day waived due to a water line break on Monday, August 26.

May Valley Elementary: One additional day waived due to a water line break on Monday, August 26.

The Floyd County Board of Education has added thirty-minutes county-wide to the school day to help meet HB 241 requirement of 1,062 hours of instruction. This allowed Floyd County Schools to make up an additional 4 days of school. The Floyd County Board of Education also voted to change two G/Planning Days for staff to instructional days for students.

An emergency day wavier is being requested so that all Floyd County Schools can dismiss students and staff on the same day, which is June 6, 2025. By granting the emergency day waiver it will allow students to attend local educational camps and other summer activities. Please contact me if you need additional information or have any questions.
