- + DISTRICT COMMITTEE, COMPRISED OF TEACHERS (JCTA IDENTIFIED), PRINCIPALS, AND DISTRICT LEADERS, MET TO REVIEW AND REVISE THE PROCEDURES IN THE SPP AND ALGF BASED ON THE WORK OF LEVEL SUBCOMMITTEES (ELEMENTARY, MIDDLE, AND HIGH).
- + COMMITTEE MEMBERS CONTINUED WORK TOWARD A LONG-TERM GOAL OF SHIFTING TOWARD
  STANDARDS- AND COMPETENCY-BASED REPORTING OF STUDENT PROGRESS.
- + Level subcommittees met to gather input from stakeholder groups, then review and revise procedures and determined recommendations for the District committee to consider and adopt.
- + COMMITTEE MEMBERS CONDUCTED A REAP AND MADE RECOMMENDATIONS FOR CHANGES BASED ON THE OUTCOME.
