Recommendation of Septic Field - Direct PO to Ray Walls Excavating DC

Studio Kremer Architects and Buzick Engineering have reviewed the septic design provided by Ray Walls Excavating. Ray Walls Excavating provided the design and coordinated with Bullitt County's Health Department to obtain a preliminarily approved septic system that will serve the North Bullitt Baseball/Softball athletic complex. Ray Walls Excavating is a Certified septic system installer as certified by the Cabinet for Health and Family Services. The work for the septic system was broken down in two phases, Phase 1 was providing of the storage tanks and pumps, this work has already been installed by Ray Walls Excavating. Phase 2 is the addition of a lateral field that will connect to the tanks already installed and complete the system as approved by the local health department.
