Thank you for your trust and confidence in Scholastic Insurance (KidGuard Insurance) for the past few years. We are excited to announce that as part of our ongoing commitment to providing exceptional service with expanding benefits, and providing comprehensive coverage solutions, that all 2025 Reliance Standard renewals will be underwritten by Everest Reinsurance Company, an A+ rated carrier by AM Best. Your current Student Accident Insurance program will automatically transition to Everest Reinsurance Company with no action required on your part other than signing and returning this Authorization form prior to your current policy's expiration date of 7/1/2025. Official non-renewal notice from Reliance Standard, a state required formality, is included with this Renewal Authorization.

Your 2025-2026 Everest renewal policy will include more generous benefits (see pg. 4) **WITHOUT impacting your premium**, along with the four entirely new and extremely valuable benefits that enhance protection for your students below:

- 1. **Home Tutoring Benefit**: Provides up to \$5,000 in coverage when a covered loss prevents a student from attending school.
- 2. **Expanded Medical Treatment Benefit**: Extends coverage to include benefits for injuries caused by repetitive motion, strains, sprains, hernia, tennis elbow, tendonitis, bursitis, and muscle tears.
- 3. **Extended Dental Treatment Benefit**: Benefits for treatment, repair, and replacement of each injured natural tooth, including examination, diagnosis, x-ray, restorative treatment, endodontic services.
- 4. **Crisis Death Benefit**: Provides additional coverage when a student's death is caused by another person's use of a gun, knife, or other deadly weapon in an *Act of Violence* while insured under this Policy.



Important points about this transition:

Catastrophic Accident coverage is also renewing. also with <u>no rate increase</u>. Catastrophic Coverage is coverage that schools purchase that cover more serious injuries to students that require prolonged recovery periods. This coverage has a \$25,000 deductible that dovetails with the maximum on the Student Accident policy. Once medical expenses reach \$25,000 on the Student Accident policy, the CAT policy is triggered with higher maximums (\$5M) and longer benefit periods (10 years).
