## CONTRACT FOR PHYSICAL THERAPY SERVICES

In a cooperative effort to provide services to students in Allen County, the party of the first part M & M Rehab Physical Therapy, and the party of the second part (the Allen County Board of Education), shall provide a joint educational and therapeutic program during the 2025-2026 school year.

Therapists will provide therapy evaluations and treatment in accordance to accepted state and national guidelines. M & M Rehab will provide Physical Therapy services which will include the following:

- PT initial evaluations and IEP goal development
- Physical therapy treatments
- Supervisory visits by the PT
- ARC meetings
- Consultations
- Documentation in Medicaid Billing System / Goal Monitoring
- Letters of Medical Necessity for student equipment

M &M Rehab will maintain and provide copies of:

- All licensure, medical tests, and certifications for the therapists as required for practicing physical therapy in the Commonwealth of Kentucky.
- Documentation of insurance.

M & M Rehab will comply with district requests for background checks on all therapists working in the school district. Therapists working within the school district agree to maintaining confidentiality.

Allen County Schools will provide any equipment or necessary space/privacy as needed after consultation with the therapist(s) on an individual basis and shall maintain all required documentation.

Payment for services will be made to M & M Rehab, LLC.

- Pay rate of \$65 per evaluation, treatment, supervisory visit, and ARC meeting.
- \$65 per consult if duration is 30 minutes. Will not charge for consultation under 30 minutes.
- No charge for screenings to assess need for therapy services.
- \$65 for documentation for equipment letters of medical necessity.
- \$65 is charged for administration of all standardized tests and another \$65 is charged for the report write-up for the standardized test.
- \* Documentation, service logs, and invoices will be completed and turned in by the 5th of the following month of treatments. Payment for services will be mailed after each monthly board meeting.
- \* Mileage and documentation time will NOT be billed except documentation for standardized tests and equipment letters of medical necessity.
- \* Telehealth visits are billed the same as face-to-face visits.

This contract will remain in effect for (1) one year from this date of July 31, 2025. At the end of this period the contract may be renewed. The contract may be discontinued by mutual agreement of the parties or either party giving written notice to the other party thirty (30) days prior to termination.
