Recommendation/Motion: Accept the recommended bids with Alternates #1, 2 and 3 as submitted outlined below; authorize the Superintendent to execute the standard American Institute of Architects (AIA) A101 contracts (KDE Version) with each awarded bidder, subject to review/approval of the FCPS General Counsel; and approve a revision to the BG-1 Project Application for a total of \$50,556,179.90 (Fifty Million, Five Hundred Fifty-six Thousand, One Hundred Seventy-nine Dollars and Ninety Cents), for the construction of the New Elementary School on Greendale Road.

Background/Rationale: The construction of the New Elementary School on Greendale Road is listed as priority 2.a.1. on FCPS's 2021 District Facility Plan (DFP). Sherman Carter Barnhart Architects and Codell Construction produced construction documents for bidding to serve 750 students (K-5). The program is consistent with other recent FCPS school projects. The project is planned to start construction in Spring 2025 and final completion is planned for Spring 2027. On March 27, 2025, bids were received on 21 of the 22 bid packages. One bid package did not receive a bid. At the Board's April 28, 2025, meeting the Board approved rejecting two (2) of the bid packages and rebidding one (1) bid package, for a total of three (3) bid packages. The recommended results of the March 27, 2025 (19 bid packages) and May 1, 2025 (3 bid packages) are listed below.

Proposal: Based on the review of these bid proposals, the FCPS staff, construction manager, and the design consultants recommend acceptance of the bids with Alternates #1, 2 and 3 as outlined below:
