## **MEMORANDUM OF AGREEMENT**

Between Madisonville North Hopkins High School Golf Teams (girls and boys) And Lakeshore Country Club

This Memorandum of Agreement (MOA) is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2025, by and between Madisonville North Hopkins High School, hereinafter referred to as "MNHHS," and Lakeshore Country Club, located at, hereinafter referred to as "LCC."

### **Purpose**

The purpose of this MOA is to establish the terms and conditions under which the Madisonville North Hopkins High School golf teams (boys and girls) will be allowed to use the facilities of Lakeshore Country Club for practices and matches during the high school golf season.

### **Terms and Conditions**

## 1. Facility Use

LCC agrees to allow MNHHS golf teams access to the golf course, driving range, and practice greens for scheduled practices and matches during the designated KHSAA golf season. All player guidelines and rules must be followed.

#### 2. Schedule

- MNHHS will coordinate with LCC staff in advance to schedule practice times and home match dates no less than 7 days in advance. This includes all practices, practices rounds and matches/tournaments.
- LCC will make reasonable accommodations based on course availability.
  Practices will not begin prior to 4:00 pm during school calendar days.
  When school is not in session, practices may take place in the morning when possible.
- o HCCHS golf teams may contact the LCC staff to see availability for the usage of the course and/or facilities 5 days in advance when MNHHS golf team is not utilizing the course. On days that MNHHS is NOT using the course, HCCHS may request the use of the LCC facilities with the same terms and conditions as MNHHS. All events shall be scheduled in Eventlink for HCPS. HCCHS administration and coaches will have access to the schedule to determine availability.

# 3. Supervision & Conduct

- All MNHHS golf team practices and matches will be always supervised by a school-appointed coach or staff member and present.
- Students will be expected to follow all LCC rules, dress codes, and standards of conduct while on LCC premises.
- Approved golf attire is to be worn at all times.

# 4. Liability and Insurance

- MNHHS will maintain appropriate liability insurance coverage for its students and staff while on LCC property.
- LCC will not be held liable for injuries or accidents occurring during practices or matches, except in cases of proven negligence on the part of LCC.

#### 5. Fees

o The Hopkins County Board of Education will pay LCC a fee of \$1.700.00 annually for the use of the course and its facilities during this time to include 1 large basket of range balls for practice, 1 small basket of range balls for a 9 hole event.

#### 6. Golf Carts

 The use of golf carts for practices will not be allowed unless authorized by the LCC staff.

# 7. Duration of Agreement

This agreement will be effective from July 10 2025, and will remain in effect through the conclusion of the 2025 high school golf season, unless terminated earlier by either party with written notice of at least 30 days.

## 8. Amendment & Renewal

This MOA may be amended in writing by mutual consent of both parties. Renewal discussions for future seasons will occur prior to the start of the next golf season.
