#### Curriculum, Instruction, Assessment

- Guaranteed & Viable K-12 Curriculum
  - Sara and I are working on a one-stop shop for housing our K-12 Curriculum. We've also updated our Curriculum, Instruction, and Assessment portion of the website that is linked <u>here</u>. We've met with both buildings to start the slow roll out of this work and will continue through the remainder of the year / summer months so we can hit the ground running for the 25.26 school year!
- Sophomore ACT Data
  - We received the scores from our 10th Grade ACT session in April:

■ Composite: 16.65

■ Math: 16.81

■ Science: 17.16

■ English: 15.65

■ Reading: 16.65

- I will work with the BHS team to ensure we are creating a growth plan for these students so they are ready to hit benchmark when they take the ACT again in Spring of 2026.
