I. Call to Order

Chairman Joe Ray Thornbury called the meeting to order and began with a moment of silence afterward, leading attendees in the Pledge of Allegiance.

B. PES Principal's Report

Principal Glenda Adkins shared with a brief recap of activities of both academic and athletic achievements.

C. PHS Principal's Report

Principal Brandon Blackburn shared with a brief recap of activities of both academic and athletic achievements.

D. District Administrator Reports

Instructional Supervisor Kim Clevinger provided an update on several key initiatives. She discussed the progress and implementation of Individual Learning Plans (ILPs), highlighting their role in personalizing student learning and improving educational outcomes. Kim also reported on the Leader in Me Lighthouse meeting, emphasizing its focus on fostering leadership skills and a positive school culture. Additionally, she outlined the activities of the Science Professional Learning Community (PLC), which is dedicated to enhancing science instruction through collaborative efforts. Lastly, she shared the science plan, which aims to align curriculum with state standards and incorporate innovative teaching strategies to engage students.

Director of District Programs/DAC Taffie Wells provided insights into several key areas. Mrs. Well presented the Career and Technical Education (CTE) End-of-Program (EOP) results, highlighting achievements and areas for improvement. She also outlined the schedules for the Kentucky Summative Assessment (KSA) and Advanced Placement (AP) testing, ensuring alignment with educational goals. Additionally, she described the "Portrait of a Learner" initiative, which integrates various educational programs, such as Amanda Robinson's innovative approach to teaching coding and pollination to 1st graders. Also mentioning the "Debt and Destiny" program for 8th and 12th graders, which prepares them for future financial literacy and career planning. Furthermore, she discussed the upcoming 6th-grade trip to the science challenge center, emphasizing how these activities connect with the "Portrait of a Panther," Leader in Me, and Individual Learning Plans (ILPs) to create a cohesive educational experience.

Ashla Vanhoose, Director of Special Education/Preschool Director shared updates on several key initiatives. She discussed the outcomes of the recent spring leadership meeting, focusing on strategic goals for preschool education. Ashla highlighted the Preschool GMAP, emphasizing its role in assessing and improving preschool program effectiveness. She also mentioned Brenda King's training on progress monitoring, which aims to enhance educational support for students. Additionally, she spoke about the collaboration with the KY Autism Training Center to implement effective behavior structures and promote a well-rounded educational approach. Lastly, she touched base on the Preschool Pyramid Behavioral Intervention Team (BIT), and how it has provided support for positive behavior and learning environments in preschool settings.

Frosty Davis, Director of Pupil Personnel provided an update on school attendance figures. PHS reported an attendance rate of 94.5%, while PES recorded 93.5%. Mr. Davis expressed gratitude to the community, staff, and clerks for their efforts in emphasizing the importance of education. He also discussed the home hospital bill, explaining its implications for students requiring medical leave.

Neil Arnett, District Technology Coordinator, spoke about several important upcoming events and initiatives. He detailed the STEAM Night scheduled for April 26th, which will focus on engaging students with activities in science, technology, engineering, arts, and mathematics. Mr. Arnett also highlighted the Student Technology Leadership Program (STLP) and its ongoing efforts to develop students' digital competencies. He announced the opening of online registration for Kindergarten and new students, designed to simplify the enrollment process. Additionally, he proposed a thorough review of the Acceptable Use Policy to ensure it meets the evolving technological and educational standards.
