### **Division 01: General Requirements**

01.01: 2025.04.29 – Roof protection was in place at exterior roof patios where being used for material delivery.

### **Division 04: Masonry**

04.01: 2025.04.29 – Brick veneer was largely complete. Scaffold was being erected for the remaining work at the entry.

04.02: 2025.05.13 – Brick veneer was complete at the entry. The mason appears to be complete except for cleaning, sealing, and caulking.

### **Division 05: Metals**

05.01: 2025.04.29 – It was reported the steel erector's crane would be removed from the site later in the week.

05.02: 2025.04.29 – The decorative railing at the open stair had been installed. Several issues were discussed. Guardrails had been installed at exterior patios except where omitted for material deliveries. 05.03: 2025.04.29 – Exterior CFMF appeared complete.

### **Division 06: Woods and Plastics**

06.01: 2025.04.29 – Exterior sheathing appeared complete outside of roof patio fascias, though not all sheathing had received spray-applied air barrier.

06.02: 2025.04.29 - Fire blocking / firestopping installation was progressing.



### **Division 07: Thermal and Moisture Protection**

07.01: 2025.04.29 - Spray-foam insulation installation had begun at the third floor and first floor.

07.02: 2025.04.29 – Air barrier had been applied to all exterior walls except, Area B (west) and Area A (east).

07.03: 2025.05.13 – Air barrier installation was complete except Area A (east).

07.04: 2025.05.13 - Roof cap sheet was 75% complete over board room.

#### **Division 08: Doors and Windows**

08.01: 2025.04.29 – First floor, Area B window framing had been delivered as had glass for Area B, second and third floor east windows. Some glass had been installed at the east side of the second and third floors. 08.02: 2025.05.13 – First floor, Area B glass had arrived and had been installed.

### **Division 09: Finishes**

09.01: 2025.04.29 – Interior gypsum board had been hung in multiple locations following inspections and where risk of moisture damage was less likely. Sound batt installation was proceeding as well. Interior CFMF was largely complete. Miscellaneous partitions and soffits remained.

09.02: 2025.05.13 – Interior gypsum board was being hung in the board room and had progressed at the first floor. The GC was advised to keep an eye on water intrusion resulting in water damage as the envelope was not weather tight.

### Division 20-28: MEP

20-28.01: 2025.04.29 – Sprinkler piping had been installed over much of the board room.

20-28.02: 2025.04.29 - Unit heaters had been installed in Receiving #150.

20-28.03: 2025.05.13 – Geothermal well field installation was nearing 50% completion.

20-28.04: 2025.05.13 – Electric panel and transformer work had progressed on the first floor. Rough-in inspection had occurred at third floor.

#### **Division 31: Earthwork**

31.01: 2025.05.13 – Earthwork was proceeding at the entry drive. It was reported proof-roll of south parking lot extension was imminent.


