HISTORY/BACKGROUND:

Government Accounting Standard No. 54 requires division of the General Fund Balance into categories based upon constraints placed on the funds. The four categories are 1) Restricted 2) Committed 3) Assigned and 4) Unrestricted. Restricted and Committed appropriations are to be identified by the Board prior to the end of the fiscal year.

At this time, the following items have been identified for Restricted or Committed Fund Balance appropriations at June 30, 2025. The reported amounts are estimates at this time. Actual amounts will be calculated at June 30, 2025 and reported to the Board with the Annual Financial Report in August, 2025.

Committed – SBDM Carryover	\$ 790,000
Committed – Sick Leave Payable	\$ 705,000
