#### **COMMUNICATION**

**In Season Game Adjustments**

Game changes – cancellations, reschedules, formats – are a reality of any season. Your Athletic Administration will make every effort to accommodate any adjustments to schedules as the season progresses. HOWEVER – there may be situations where adding games or cancelling games ( JV and Freshman contests when officials have already arrived on site ) becomes cost prohibitive to the scheduled athletic officials budget. In those circumstances, teams will be asked and expected to cover the costs of the officials from their team account.

**Communication with Student Athletes**
