Recommendation/Motion: Approve a revised BG-1 Project Application for the construction of the New Henry Clay High School in the amount of \$178,900,227.60 (One Hundred Seventy-eight Million, Nine Hundred Thousand, Two Hundred Twenty-seven Dollars and Sixty Cents).

Background/Rationale: A revised BG-1 Project Application for the bid/construction, identifying the extent and cost of the work, was approved by the Board at its May 27, 2025 meeting. This revised BG1 reflects the actual costs and revenue associated with the post-bid bond sale. Based on this KDE requirement, a revision to the BG-1 is required as follows
