Recommendation/Motion: Accept the base bid as submitted by _____ authorize the Superintendent to execute the standard American Institute of Architects (AIA) A101 contract (KDE Version) in the amount of \$_____, subject to review/approval of the FCPS General Counsel; and approve a revision to the BG-1 Project Application for a total of \$_____, for the renovation of two (2) classrooms into Preschool Classrooms at Arlington Elementary School.

Background/Rationale: In the spring of 2022, the Board designated funding to support the FCPS Preschool program based upon a five-year plan. A priority of that five-year plan includes adding preschool classrooms at Arlington Elementary School. The Preschool program staff has recommended that two (2) classrooms be renovated into Preschool classrooms to serve additional children in a half-day program.

The initial BG-1 Project Application for the construction, identifying the extent and cost of the work, was approved by the Board at its April 28, 2025 meeting. GRW Engineers have produced final Construction Documents for bidding describing these modifications. The project is planned to start summer 2025 and to be completed fall 2025. On _____, 2025, _____ (____) bidders submitted proposals on the base bid. The results of the bidding are as follows:
