CHANGES IN 2025-2026 EMC RENEWAL

- 1% Wind/Hail deductible applies to the following locations:
 - Central Office/Bown Elementary/Clay City Elementary including Football stadium and Field House
 - Bus Garage/Powell County Middle School/Stanton Elementary/Main Storage Building/ Powell County School Board Annex
 - o All other buildings have \$75,000 Wind/Hail Deductible
- Earthquake 5,000,000 10% deductible/ Flood 1,000,000 \$50,000 deductible (No exclusions)
- ACV Roof Endorsements on roofs considered in disrepair.
- Comp /Collision deductible increased from \$1,000 to \$2,000 all vehicles.
- Property Damage deductible added to auto \$2,500.
- Umbrella reduced from \$10,000,000 to \$5,000,000.
 - Sexual Abuse & Molestation sublimit of \$ 2,000,000

LIBERTY MUTUAL PROPOSAL

- \$100,000 Wind/Hail deductible
- \$10,000 All Other Property
- \$ 250,000 Wind/Hail ded applies to:

ADDITIONAL SUMBISSIONS:

CM Regent – Not an option for Powell County Schools for 2025-2026. Advised that they could only offer proposals to schools with Total Insured Values below \$100M and fleet smaller than 20 buses/vehicles.

Gladfelter – Not an option for Powell County Schools for 2025-2026. Did not have \$2M primary auto coverage filed with KY Dept of Insurance as well as no School Bus Endorsement. Their coverage would not meet KDE guidelines this year.
