#### **Division 05: Metals**

05.01: 2025.06.10 – Alternating tread ladder to roof from third floor had been installed.

#### **Division 07: Thermal and Moisture Protection**

07.01: 2025.05.27 – Second floor roof hatch had arrived and had been installed.

07.02: 2025.05.27 – Areas of incomplete air barrier at the third floor above the low roof were identified and brought to Monarch's attention.

07.03: 2025.05.27 – Mineral wool insulation and z-girts had been installed on much of the west elevation.

07.04: 2025.05.27 – Spray foam insulation had been applied to the interior side of the cantilever beams above the sawtooth at the entry.

07.05: 2025.06.10 – Mineral wool insulation and z-girts appeared complete on all three floors, Area B as well as the East wall of Area A.

07.06: 2025.06.10 – Air barrier issues identified on 5/27 had been corrected.

#### **Division 08: Doors and Windows**

08.01: 2025.06.10 – Glass installation was nearly complete on all three floors, Area B. A couple of odd-sized panes were not installed.

#### **Division 09: Finishes**

09.01: 2025.05.27 – Gypsum board installation had progressed at the first and second floors, including the board room. Sound batt installation was progressing in front of board installation. Many first floor spaces had received tape and mud.

09.02: 2025.06.10 – Gypsum board installation, taping, and mudding had progressed. The first floor was nearly entirely boarded.



09.03: 2025.06.10 – Acoustic spray-insulation was nearing completion at the first floor. Second floor wall masking had started.

#### Division 20-28: MEP

20-28.01: 2025.05.27 - RTUs 1 and 2 and Condensing Units 1 and 2 had been installed.

20-28.02: 2025.06.10 – Geothermal vault was reported to be arriving 6/11. It was reported 56 of 70 borings

had been completed.

20-28.03: 2025.06.10 – Duct and hydronic piping installation was largely complete in Area B, all three floors. Insulation was on-going.

#### **Division 31: Earthwork**

31.01: 2025.05.27 – Additional grading had been completed at the south end of the site (between asphalted lot and bridge) to extend the parking area. An area of undercut was reported. We are awaiting UES report for the quantified scope.


