STUDENT LEARNING AND SUPPORT SERVICE

Superintendent Watts invited Matt Atkins, Principal at NPS, and Autumn Slankard, Instructional Coach at NPS, to present to the board regarding curriculum resources for the upcoming school year.

Mr. Atkins recommended that the board consider renewing current contracts for the school's reading, writing, and math programs. He also requested the renewal of the i-Ready contract, an online assessment tool administered three times per year. i-Ready has proven to be highly effective in helping teachers identify students' needs and guide them toward proficiency and growth in both reading and math based on assessment results.

The Wonders reading program, developed by McGraw Hill, is a comprehensive K–5 English Language Arts curriculum. It supports literacy development through an integrated mix of print and digital materials. The program focuses on foundational skills, repeated readings of texts to understand author's purpose, word meaning, and text structure, writing, and vocabulary achievement. The program also aligns with educational standards, including the Common Core.

Math in Focus, distributed by Houghton Mifflin Harcourt, is a K–8 mathematics curriculum. It promotes conceptual understanding, critical thinking, and problem-solving skills through a structured, visual, and hands-on approach to math instruction. Both Wonders and Math in Focus are evidence-based curriculum programs. Teachers plan collaboratively using these programs, provide consistent assessments, and are able to revise as needed.

What does it look like to use new materials? Full implementation of new programs takes about 4 years and scheduling PD for new programs now would make it nearly impossible to implement by August. Teachers would need to pilot any new programs by December before considering changes. With this information in mind, Newport Primary is asking the board to keep their current curriculum programs for the 2025-2026 SY.

Ms. Payne presented the Curriculum Department report. There were no questions.

Ms. Stewart presented the DPP report as well as the student services report. There were no questions.

Mr. Maines presented the Facilities, Transportation, and Safety report. He took a moment to clarify the misinformation regarding bus service next year. The district's busses will provide services for all students; there will be a schedule change regarding the start times in the schools but students will be provided transportation.

Ms. Swanson presented the Special Education department report. There were no questions.

Ms. Michael updated the board on the Big Brothers/Big Sisters mentoring program currently being piloted at the intermediate school called Game Changers. Through mentoring, training, consulting, & education, they equip children and young adults with necessary tools to make positive life changing decisions. The program has had a tremendous impact on the students so far. There is a lot of paperwork for parents to complete which slows down the process but the mentor does plan to return next year and continue the work he started this year.
