

June 2025 Monthly Financial Summary



1. Total Revenue:

- **YTD Actual:** \$31.8 million, a 12% increase from last fiscal year.
- **Budgeted:** \$29.5 million.
- **Key Sources:**
 - Local taxes: \$11.1 million collected, a 7.6% increase from last fiscal year.
 - SEEK: \$11.4 million total, a 9.1% increase from last fiscal year.
 - Interest earnings: \$345,419, a 5.6% decrease from last fiscal year.
 - There will still be some remaining revenue to be posted back into the fiscal year, including indirect costs from the food service account.

2. Total Expenditures:

- **YTD Actual:** \$22.8 million, a 10% increase from last year.
- **Budgeted:** \$25.9 million, with \$3.1 million remaining.
- **Categorical Spending:**
 - Instruction: 58.95%
 - School Level Supports: 13.09%
 - Building Operations: 11.14%
 - Student Transportation: 8.76%
 - District Level Supports: 8.05%

3. Ending Balance:

- **Current:** 17.5% higher than last fiscal year.

The overall financial outlook appears positive and healthy. The district is currently exceeding its revenue targets, with actual revenue significantly higher than budgeted and showing a substantial increase from the previous year. While interest earnings are slightly down, local taxes and SEEK have increased to offset.

Expenditures are well-managed and under budget, with a substantial amount of budgeted funds remaining. This indicates efficient spending and good cost control.

The ending balance is notably strong, being 17.5% higher than the last fiscal year, further reinforcing the positive financial position. The remaining revenue to be posted (e.g., indirect costs from food service) will only further strengthen this favorable outlook.
