Section III: Evaluate the Policy

Powell County will:

1. Conduct, with meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of the parent and family engagement policy in improving the academic quality of all schools served by Title I, including identifying:
 - a. Barriers to greater participation by parents in activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). Families will be surveyed and provided opportunities to identify barriers and possible solutions that would be helpful for families. District and school leaders will work with community partners to offer support for families. Family Resource Youth Service Centers will be part of the planning to reduce barriers.
 - b. The needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers. Input from all stakeholders will be collected to determine needs of families. Input will be provided through phone calls, parent-teacher conferences, survey data, and emails.
 - c. Strategies to support successful school and family interactions will be determined from the evaluation of Parent and Family Engagement activities. The district and school will schedule events at the times most requested by families and utilize communication tools most convenient for families to ensure maximum school and family interactions.
2. Use the findings of the annual evaluation to design evidence-based strategies for more effective parental involvement, and to revise, if necessary, the district and/or school parent and family engagement policies. Evaluation results will be collected via phone, email, survey, and in-person conversations. Evaluation results will be reviewed during Parent Teacher Community Organization Meetings and School Based Decision-Making Committee Meetings.

Section IV: Involve Parents at the School Level

Powell County will:

1. Involve parents in the activities of the schools served under Title I through Family Resource Youth Service Center Advisory Councils. Councils will include parents, students, staff, and community members.
2. Involve parents in the decisions regarding how funds reserved for parent and family engagement are allotted for parental involvement activities at the district and/or school level. Parent involvement for the usage of funds for Parent and Family Engagement Activities will include involving parents in the Needs Assessment for the school and district by providing a variety of ways to offer feedback.

parents understand. Translations will be provided in written form and oral form when requested. Parent teacher conferences are scheduled throughout the year and all parent requests for meetings will be honored.

2. Notify parents of this policy in an understandable and uniform format, and to the extent practicable, in a language the parents can understand. The policy will be distributed to parents and made available to parents and members of the local community in an online and print option. This policy will be reviewed with families at the Annual Title I Parent and Family Engagement Meeting.

Section VI: Policy Review and Revision

Powell County will work jointly with parents to review and revise this policy as necessary to meet the changing needs of the parents and the district. Families can provide in-person or written feedback. Families will be regularly surveyed (written and/or in-person) and various forms of data will be utilized to determine the Parent and Family Engagement needs.

EXPECTATIONS FOR PARENT AND FAMILY ENGAGEMENT

Contingent on confirmation of resources and other necessary information being provided by state and federal authorities, it is the intent of the Board that parents and family of participating students shall be provided with flexible opportunities for organized, on going, and timely participation in the planning, review, and improvement of the Title I program, including opportunities to suggest modifications, based on changing needs of parents, family and the schools.

All comments indicating parent and family dissatisfaction with the Title I plan shall be collected and submitted along with the plan to the Department of Education.

The Title I program shall be designed to assist students to acquire the capacities and achieve the goals established by law, as well as the goals and standards established by the Board. Consistent with law and policy covering student records confidentiality, these goals and standards shall be shared with parents and family in a manner that will give them: (1) timely information about programs; (2) a description and explanation of the school's curriculum, the forms of academic assessment used to measure student progress, the achievement levels in the challenging state academic standards; the achievement level of their child on the challenging state academic standards assessments; and (3) if requested, opportunities for regular meetings to formulate suggestions and to participate in decisions relating to the education of their children.

SUPPORT FOR PROGRAM

If the District's Title I allocation is \$500,000 or more, the District shall reserve not less than one percent (1%) of its allocation for the purpose of promoting parent and family engagement and shall distribute to Title I schools not less than ninety percent (90%) of the reserved funds with priority given to high need schools. Parents and family of participating students shall be provided the opportunity to help decide how this portion of the Title I funds will be allotted for parent and family engagement activities.

The District will provide coordination, technical assistance, and other support necessary to assist schools in planning and implementing effective parent and family engagement activities to improve student academic achievement and school performance. These measures may include, but shall not be limited to, the following:

1. Designation of resources to assist in communicating with parents and family, transporting them to meeting sites and/or implementing home visits, providing child care for meetings, encouraging them to use available parent and family resource centers, and
