Re: Inkwire, Inc.

The attached agreement is to utilize the Inkwire platform, which is a project-based learning tool for teachers and students in creating more learning experiences connected with our instructional vision. This agreement will help establish Inkwire as our platform to support classroom-based, school-based, and community-based student defenses, thereby aligning with BCPS's competency-based model and enhancing learning and assessment processes. The initiative comprises two main components of creating the structures competency-based evidence of learning, developing a rubrics and scoring system that incorporates our Graduate Profile Performance Outcomes and creating defense facilitation tools like structured reflection prompts and teacher dashboards. In addition, this work is part of the agreement entered in through the grant for the Innovative School Systems Grant. The total contract value for this engagement is \$111,500 which will be funded through the Center for Reinventing Public Education (CRPE) Phase II Grant through the Walton Family Foundation. This agreement has been reviewed by Dinsmore & Shohl, LLC.

Building Inkwire Capabilities to Support BCPS Defenses

Our Goal: Set up Inkwire to be a technology system to comprehensively support classroom-based, school-based and/or community-based defenses at BCPS.

This scope consists of 2 major components:

1. **Collaborative Design** through which Inkwire will collaborate with BCPS and Envision Learning Partners (ELP) to outline the core technology needs for implementation of defenses.
2. **Product Development** through which Inkwire's product team will implement new features within the platform.

1. Collaborative Design

Work closely with Bullitt County Public Schools and Envision Learning Partners (ELP) in the design of a scalable, district-wide defense framework aligned to BCPS Portrait of a Graduate and Authentic Learning practices. Through virtual check-ins, in-person collaboration, and on-the-ground piloting, identify opportunities and features to incorporate within the Inkwire technology platform.

Time: 160 hours (combination of in-person & virtual collaboration)

2. Product Development

Inkwire will utilize learnings from ongoing collaboration with ELP & BCPS to implement new features within the platform that directly support defenses. Our product development will be informed by real-time feedback from pilot implementations and continuous collaboration with both educational partners.

Tracking Competency-Based Evidence of Learning (120 hours)

Inkwire will support with the collection and analysis of student learning by:

- Allowing students to tag uploaded evidence of learning with one or more BCPS Graduate Profile competencies and key academic standards.
- Providing functionality to filter, sort, and organize student evidence of learning by selected tags, giving both students and educators visibility into progress toward learner outcomes.

Rubrics and Scoring System (120 hours)

Inkwire will support teachers with designing assessments aligned with BCPS's competency-based model by:

- Incorporating Bullitt County's enhanced Performance Outcomes into Inkwire
- Incorporating ELP's High-Quality Performance Assessment (HQPA) principles into the rubric generation and scoring system
