HISTORY/BACKGROUND:

During the 2025-2026 school year, River Ridge Student Nutrition Department will furnish fifteen breakfast meals and fifteen lunch meals per day to the Learning Grove program at River Ridge Elementary School. The Student Nutrition Department will be paid adult meal prices for breakfast and lunch. The estimated amount to be paid by Learning Grove is \$19,197.00.
