Proposal 26 - This change order is to support air devices, clean, and reinstall into the new grid in each of the back classrooms. Existing air devices were indicated in what appeared to be existing ceiling grid; however, one of the main issues encountered is the ceiling grids not going back in the same location so the contractor had to support and reinstall grilles attached to hard ductwork where the ceilings shifted, up to 6-12 inches in some areas. ADD \$17,336.

Proposal 40 - Custom door size was required in one location as it was an odd existing size. This cost is only for the upcharge of the custom manufactured one. ADD \$2,381.

Proposal 42 - Due to higher than anticipated elevations of the electric conduit, it was advised to raise the retaining wall slightly to provide Duke with 3! of cover. ADD \$19,172.

Proposal 44 - This change order is for redoing the flooring in the end zones of the Gymnasium, adding new rubber flooring at other miscellaneous small areas, and installing a solid surface panel behind one of the drinking fountains. ADD \$39,668.
