MUNICIPAL ORDER 15-2025

A MUNICIPAL ORDER AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE AN EASEMENT AGREEMENT BETWEEN THE CITY OF OWENSBORO AND REGIONAL WATER RESOURCE AGENCY, GRANTING A PERPETUAL EASEMENT FOR THE PURPOSE OF CONSTRUCTING, OPERATING, MAINTAINING AND RECONSTRUCTING A SEWER LINE ACROSS A PORTION OF PROPERTY LOCATED ON CARTER ROAD.

WHEREAS, Regional Water Resource Agency (hereinafter "RWRA") requests a perpetual easement for the purpose of constructing and thereafter operating, maintaining and reconstructing a sewer line over and across a portion of property located on Carter Road, as shown on the attached Exhibit "A"; and

WHEREAS, the granting of a perpetual easement has been fully reviewed by city staff and will not unreasonably interfere with the use of the property located on Carter Road.


NOW, THEREFORE, BE IT ORDERED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

Section 1. That the Mayor be, and he hereby is, authorized and directed to execute a Deed of Easement by and between the City of Owensboro and RWRA, under the terms of which the City shall grant a perpetual easement over a portion of property located on Carter Road in order for RWRA to construct and thereafter operate, maintain and reconstruct a sewer line.

Section 2. That the Mayor, City Manager, City Engineer and other staff members are hereby authorized to execute any and all other agreements, instruments or

documents deemed necessary and appropriate to effectuate and implement this easement agreement.
