6. ORDINANCES – 2nd READING

6.A. Ordinance 10-2025 entitled AN ORDINANCE AMENDING CHAPTER 3, ARTICLE III, SECTION 3-57 OF THE OWENSBORO MUNICIPAL CODE RELATING TO THE ENTERTAINMENT DESTINATION CENTER TO ALLOW IT TO BE ENJOYED AT ALL TIMES ALCOHOLIC BEVERAGES ARE SOLD, was unanimously approved on second reading by a roll call vote. Motion was made by Commissioner Sanford and second by Commissioner Maglinger.

The City created an Entertainment Destination Center (EDC) in the Owensboro riverfront area, which has been successful and popular with visitors in downtown Owensboro. The City now seeks to allow visitors to enjoy the EDC at all times alcohol is sold by establishments within the EDC. City Manager Pagan explained the amended ordinance will allow alcoholic beverages to be carried in special cups within the EDC at all times when alcohol is being sold.

7. ORDINANCES - 1st READING

7.A. Consider Ordinance 11-2025 entitled AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING JUNE 30, 2026, AND AMENDING ORDINANCE 6-2025 TO REVISE BEGINNING FUND BALANCES, CARRY OVER APPROPRIATIONS FOR ALL OUTSTANDING ENCUMBRANCES, CAPITAL PROJECTS AND RE-BUDGET FUNDS, was introduced and publicly read on first reading.

Budget amendment to revise beginning fund balances, carry over appropriations for all outstanding encumbrances, capital projects and re-budget funds. City Manager Pagan explained the majority of the amendments were multi-year capital projects carried over; others may be purchases that have not been received/paid for yet. The one new item is for a cybersecurity program for Central Dispatch.

Three female veterans have joined the planning committee to help create the vision. George Lundeen, the artist who created the Nicky Hayden statue, has agreed to create the sculpture. The vision is to honor the WWII, modern day and future female veterans. Army Veteran Natasha Conkright (3344 Brookfield Drive) mentioned the two decorated Army veterans from Owensboro, Mary Josephine Oberst and Vivian Hayden Lawton and added that the monument would be dedicated to all women who have served in the military. She also requested the WWII Memorial be restored.
