AMENDMENT TO THE AGREEMENT BETWEEN GARRARD COUNTY PUBLIC SCHOOLS AND THE UNIVERSITY OF KENTUCKY

I. <u>INTRODUCTION:</u>

A certain Agreement was entered into between the University of Kentucky, College of Medicine, Department of Orthopaedic Surgery and Sports Medicine, hereinafter known as "UK", and Garrard County Public Schools, hereinafter known as "GCPS", as of July 1, 2024, for the provision of athletic training services (the "Agreement"). This Amendment made and entered into this 1st day of July, 2025 amends that certain agreement between the parties.

II. MODIFICATION:

Section IV(A) of the Agreement is hereby deleted in its entirety and replaced with the following:

A. Financial Compensation

In addition to the GCPS responsibilities listed above, and in consideration of the services provided by UK as described above, GCPS agrees to remit the following sums annually to UK as directed below:

\$35,000.00 (for the period July 1, 2024 through June 30, 2025) \$76,000.00 (for the period July 1, 2025 through June 30, 2026)

UK shall invoice GCPS for one-half of the annual fee on December 1 of each year and shall invoice the remaining balance on May 1 of the following year. GCPS shall remit payment for each installment due within thirty (30) days of the invoice date to the following address:

Section V(A) of the Agreement is hereby deleted in its entirety and replaced with the following:

A. This Agreement shall run from July 1, 2024 through June 30, 2026. At any time during the term of this Agreement either party may terminate this Agreement without cause by providing thirty (30) days' written notice to the non-terminating party.

II. <u>TERMS AND CONDITIONS</u>:

& Sports Medicine

Except as modified by this Amendment, the Agreement shall continue in force and effect in accordance with its terms. In the event of a conflict between this Amendment and the Agreement, the provisions of this Amendment shall govern.
