MEMORANDUM OF UNDERSTANDING

Between Christian County Public Schools and Pennyroyal Healthcare Services, Inc. DBA Community Medical Clinic

This Memorandum of Understanding (MOU) is entered into by and between Christian County Public Schools, hereinafter referred to as "CCPS," and Pennyroyal Healthcare Services, Inc. DBA Community Medical Clinic, hereinafter referred to as "CMC," collectively referred to as the "Parties."

I. Purpose

The purpose of this MOU is to establish a partnership between CCPS and CMC to provide on-site healthcare services to students and staff through the use of CMC's Mobile Health Unit. Services will include wellness visits, vaccinations as needed, and sick visits for students and staff.

II. Scope of Services

Under this agreement, CMC will:

1. Provide a licensed Mobile Health Unit to visit designated CCPS school sites on mutually agreed dates and times.
2. Offer wellness visits for students, which may include routine physical exams and vaccinations as needed.
3. Provide sick visits for students and staff, as needed, during designated times.
4. Ensure all services are provided by qualified, licensed healthcare professionals in compliance with applicable federal, state, and local laws and regulations.
5. Maintain all necessary medical records in compliance with HIPAA and FERPA regulations.

CCPS will:

1. Provide a safe and accessible location on school grounds for the Mobile Health Unit to park and operate.
2. Assist with coordinating scheduling and communicating available services to parents/guardians, students, and staff.
3. Obtain and maintain any required parental/guardian consents for students to receive healthcare services.
4. Support promotion of the partnership and services offered through approved school communication channels.

III. Term and Termination

This MOU shall become effective on the date of the last signature below and shall remain in effect for one (1) year, unless terminated by either party with thirty (30) days' written notice. The MOU may be renewed upon mutual agreement in writing.

IV. Confidentiality

CMC agrees to comply with all applicable confidentiality laws and regulations, including HIPAA and FERPA. CCPS agrees to assist in ensuring compliance as needed.

V. Liability

Each party shall be responsible for its own acts and omissions, as well as those of its officers, employees, agents, and contractors.

VI. Non-Discrimination

CMC agrees to provide services without discrimination based on race, color, national origin, sex, disability, or age.

VII. Miscellaneous

This MOU constitutes the entire understanding between the Parties and may only be amended in writing signed by both Parties. This MOU shall be governed by the laws of the Commonwealth of Kentucky.
